Board of Elders Minutes

January 7, 2013

Members present: Rev. Don Griffin, Bobbie Reid, Dwight Deal, Cindy Johnson, Karen Kapp, Sylvia Ridge; absent: Walter Carter, Pam Hensdale, David Long

Rev. Griffin shared a devotional, and numerous prayer concerns of the congregation were updated before prayer.

Updates:

- **Outreach Ministry** – The next canvas will focus on current members of the congregation who have had an extended absence from active membership. Joint Board members will be encouraged to be part of this particular Outreach Ministry team effort. The canvassing date has not been determined.
- **SOP (Standard Operating Procedure) for Scout Hut/Pavilion, Afterschool Building, and Flinchum House** – Cindy Johnson and a Trustee (to be determined) will work with Terry Tucker to establish a SOP for these supplementary buildings so everyone may understand how each member of the congregation may utilize these shared resources.
- **Bible Study – Sunday evenings, 5:30-6:30 pm, starting January 13, 2013** – Pastor Don, Steve Williams, Marcia Williams, and Anita Whittington will rotate teaching responsibility each week as they present a Bible study on the book of Romans. Jack & Janice Reich have volunteered to prepare a welcoming meal (4:30-5:15 pm) for the first Bible study meeting. Thereafter, the Reich's can decide how to offer a meal.
- **Praise & Worship Leader** – The Trustees have established a Praise & Worship Leader position similar to the Choir Director and Accompanists already associated with the Traditional Worship service. The Elders approved a Job Description for this new position. The position will be advertised in the bulletin. Anyone interested should provide a resume to the church office. Sylvia Ridge and a Trustee (to be determined) will conduct the interviews with job candidates.
- **Clothes Closet Ministry** – The Clothes Closet successfully hosted a Christmas open house offering clothes, children's toys, and fellowship to numerous visitors in December.
- **Heart Sunday** – A special memorial remembrance of our loved ones who have departed into the more immediate presence of their Savior, Jesus Christ, over the past year (2012) will be observed on February 10, 2013, during the 11:00 worship service. Members are encouraged to contact the church office with the names of loved ones they want included in this memorial.

New Business:

- **Church Council – January 27, 2013** – The work of the Nominating committee continues. Dwight Deal will be in charge of organizing the congregational luncheon following worship just prior to church council. The Joint Board will assist in serving the meal. The Nominating committee will serve as Tellers during the election process. Newly elected Joint Board members will be installed at the conclusion of church council. Retiring Joint Board members are asked to attend the February meetings of their Board to assist in a smooth transition of the new Joint Board.
- **Share the Warmth** – Karen Kapp received Elders' permission to organize a pancake supper as a Duke Energy Share the Warmth fundraiser on January 29, 5:00-7:00pm.
- **Christian Music Concert** – Permission was given for Casey Brown to organize a concert of Christian music performed in the Sanctuary. A love offering will be collected at the concert for the musical group(s).
- **Liaison to Union Cross Academy** – Bobbie Reid agreed to continue as the congregational liaison to Union Cross Academy, informing the congregation of opportunities to assist their students.

Board of Trustees Minutes

December 10, 2012

Karen Vaughn opened the meeting with devotions.

Treasurer's Report – Lisa presented the financial statement for the period ending November, 2012, as well as the budget for 2013. She noted that the electrical upgrade has been completed, and expected to pay the bill before the close of 2012. The Board discussed various items relating to the upcoming budget and made several changes to accommodate church infrastructure repairs and improvements in 2013. The Board voted unanimously to leave all salaries at current levels. The 2013 church budget was unanimously approved as amended.

Proposed Additional Church Positions – The Board discussed two suggestions regarding the addition of two positions to the church's budget.

Cleaning/Building and Grounds Employee – The Board discussed various tasks and responsibilities that could be assigned, including making sure all equipment was in proper order and fueled for volunteers to mow. No decision was made regarding the establishment of this position. Upon motion by Barry and second by Charles, the Board unanimously agreed to consider this in future meetings.

Praise and Worship Leader – After thorough discussion and input from all Board members, Barry made a motion to establish this position as a salaried position, to request that the Board of Elders prepare a job description, and to advertise the vacancy. The motion was duly seconded by Jerry. The motion carried upon a majority vote.

Schools Ministry Update – A gate has been installed around the window wells for the Pre-School area, and appreciation was expressed to Ronnie and Jerry for handling this safety improvement.

Pavilion Anti-Erosion Update – Beth advised that she met with the Board of the local Community Assistance Program office regarding potential funding assistance to address erosion around the church pavilion. She stated that the church does not currently qualify for assistance due to relocation of the pavilion occurring within the past three years. She explained that the CAP staff offered several recommendations for improvements which may include moving the parking area.

Remains Structure – Beth informed the Board that the church would be allowed to erect a remains structure without a permit as long as the structure did not exceed eight feet in height.

Sanctuary Video Screen and Enhanced Sanctuary Lighting – No additional information.

Door Replacement – Charles reported that he is still waiting on a quote for replacement and/or repair of doors.

Trophy Case Update – No additional information.

Scout Hut Bathroom – The permit has not yet been approved due to some needed changes.

RightNow Ministries – This is an on-line resource which could be used by almost all groups in the church for Bible studies, devotions, and Sunday School lessons. Upon motion by Paige and second by Barry, the Board unanimously voted to add \$1,200 to the 2013 budget, with the understanding that use of the resource would be evaluated in six months.

Praise Area Stage – Barry volunteered to take a lead role in fundraising for improvements to the Praise and Worship area, included, but not limited to, wireless microphones, LED lighting, and permanent stage. This matter will be further discussed in January.

Playground Equipment – Charles asked what was being done to address safety issues of the playground equipment. Barry stated that he will speak with Dan and others regarding ideas for improvement and enhancement of the playground equipment.

There being no further business at this time, the meeting was adjourned at 9:16 p.m.

NOTE: Following the worship service on December 30, the Trustees held a brief meeting and approved \$150 for the purchase and installation of a diaper changing shelf in the former men's bathroom in the narthex of the sanctuary.

Karen Vaughn opened the meeting with devotions.

Treasurer's Report – Lisa presented the financial statement for the period ending December, 2012, as well as the updated budget for 2013. Upon motion of Barry and seconded by Ronnie, the Board unanimously approved the transfer of \$4,500 into the building fund due to a specific designation.

Petty Cash Debit Card - Lisa recommended that the church secretary have a debit card to use for stamps and petty cash purchases. Paige made a motion to approve a debit card with a \$200 per month limit. The motion was duly seconded by Karen and unanimously carried.

Approval of December Minutes – Charles made a motion for approval of the December minutes as presented. The motion was seconded by Ronnie and unanimously carried.

Schools Ministry Update – There was discussion regarding access to the Pre-School Director's office. Barry made a motion to allow the office door to remain locked with the placement of a duplicate key in a location accessible to the church secretary, pastor, and chair of the Board of Trustees. A copy will also be placed in the church's Knox box. Dan seconded the motion and it was unanimously carried.

Pavilion Anti-Erosion Update – Lisa stated she will look back in the financial records to determine when the check was written to the contractor who moved the dirt. The church should be able to qualify for financial assistance from the local Community Assistance Program to address erosion around the church pavilion after three years from the date of the initial grading work.

Sanctuary Video Screen and Enhanced Sanctuary Lighting – No additional information.

Sanctuary Ceiling Painting – No action until video and lighting options are determined and installed.

Door Replacement – No additional information.

Scout Hut Bathroom – Tim Smith is waiting on the redrafting of the plans based on the Inspections report. The Board agreed that this project needs to be expedited so the facilities will be ready for spring.

Fundraisers for 2013 - Barry discussed various fundraisers to finance improvements to the Praise and Worship area, including, but not limited to, wireless microphones, LED lighting, and permanent stage. Reverend Griffin suggested that Barry provide a brief written synopsis for each improvement.

New Advent Star – Reverend Griffin advised that a member of Home Moravian Church, Max Brady, has offered to teach interested church members how to make a new Advent Star for our church sanctuary. Reverend Griffin stated that he will provide additional details after he has a chance to talk further with Max, but it is his understanding that Max will provide the materials and hold a workshop for volunteers to make the new star at no cost. Max has provided replacement stars for several Moravian churches in the area as well as one for Davis Chapel at Baptist Hospital. Dan made a motion to gratefully accept Max's offer. The motion was duly seconded by Ronnie and unanimously carried.

Union Cross Road Forum – Barry stated that he saw an announcement in the Kernersville News about a meeting at Union Cross Academy on Tuesday, January 15, at 6:00 p.m. regarding development in and around the Union Cross community. He noted that he was planning on attending and wanted to pass along this information in case anyone else was interested.

Offertory Collections – Beth suggested that time be allowed for an offering during the Praise and Worship service.

Share the Warmth Fundraiser – Karen stated that Karen Kapp has requested permission to organize a pancake supper on Tuesday, January 29, for the Share the Warmth program. Ronnie made a motion for approval. The motion was seconded by Barry and unanimously carried.

Church Council/Newly Elected Board Members – Reverend Griffin advised that he wanted to install the newly elected Board members immediately after Church Council on January 27. The new Boards can then elect officers and set committee assignments at the February meeting to be ready by the effective term date of March 1. Upon motion of Barry and second of Karen, this suggestion was unanimously approved.

Cremaains Wall – Beth stated she is ready to make a presentation and proposal to Church Council and the Graveyard Board. Reverend Griffin will place this as an item on the agenda for Church Council and advise the chair of the Graveyard Board.

Custodial Duties of Trustees – Jerry asked if individual trustees conducting custodial duties following Sunday worship also sign off on offerings. Several members of the Board were unaware of this responsibility. Beth made a motion to update the procedures for custodial duties so everyone will have a clear understanding of what is required. The motion was seconded by Ronnie and unanimously carried.

There being no further business at this time, the meeting was adjourned at 8:48 p.m.

The RCC discussed the Lovefeast that was held at Carter G. Woodson School. The Lovefeast had ~194 people present. Some of the children were unfamiliar with some of our songs and were hesitant to sing. There was a suggestion that maybe for next year's Lovefeast with the school that we try to get a choir to help lead them in song. Some suggestions were the girls' choir at Glenn High, or choir members from the RCC churches or a choir from WS State.

Enterprise Moravian reported that they have been having Bible Study with Mt. Olivet United Methodist Church and have had successful attendance at the meetings.

Pine Chapel will be having a Spaghetti Supper on Saturday February 9th and a Pancake Supper on February 12th.

Friedland Moravian reported that they will have a Community Day on April 27th with games and a mini "mud run". Also, on May 18th they will have a full fledged Super Hero Mud Run to benefit Sunny Side Mission. There will be a registration fee and prizes awarded. We will be getting more details as the event continues to be finalized.
