

Fact Sheet

Duke Energy Rate Hikes:

Proposing 14% increase for residential consumers

If approved, residential rates will be 30% higher than in 2009.

Duke's proposal guarantees them a profit of 11.25% but we foot the bill

Duke/Progress Long Term Energy Plan:

Duke/Progress plans to raise consumers' rates to pay for unnecessary power plants.

- The business plan will raise rates annually to pay for new power plants even though long-term electricity demand is decreasing.
- Other states are developing energy-saving programs that reduce costs and generate thousands of jobs.
- Duke Energy <u>does</u> provide clean energy in areas of the country where they don't have a monopoly and there is competition among other energy providers
- In NC, Duke Energy exercises its monopoly power through unnecessary rate hikes, increased nuclear power plant investment and a refusal to invest in clean energy.

The plan relies on expensive, dirty energy instead of cheaper, cleaner methods.

- The plan includes doubling capacity from natural gas (fracking) with no reduction in capacity from coal.
- The proposed plan includes only a fractional increase in clean energy capacity (solar and wind) in the next 20 years. (NC WARN)

North Carolina's Economic Reality:

Duke is out of touch with the economic reality of its residential consumers.

- NC has the 5th highest unemployment in the U.S. (9.2% vs. 7.5% nat'l avg.)
- Over 50% of NC's counties have double-digit unemployment rates


